Research Spotlight:

How Weatherization and Home Improvements Can Help the Elderly

Just as COVID-19 is disproportionately affecting older Americans, so too do many other health problems such as asthma and other respiratory diseases as well as trip and fall accidents. For many of these non-COVID problems, weatherization and home repairs can help keep older adults safely in their homes. Our <u>new paper</u>, which reviews medical

and public health literature, suggests ways to add home repairs to weatherization programs and add weatherization to programs for the elderly. As America rallies to protect the elderly (and others) from COVID, hopefully we can also rally to help meet some of their other health needs.
